

RESEARCH CV FOR ASSOCIATE PROFESSOR TREVOR CULLEN -

In February 2017, I was appointed **Associate Dean for Design, Media and Communications** in the School of Arts and Humanities (SAH) at Edith Cowan University in Perth, Western Australia. Prior to this appointment, I had been Program Director.

In April 2016, I was appointed **Director of CREATEC** - a Level 2 Research Centre for Creative Arts, and in December 2016, I received an **Australian Award for Excellence in University Teaching** (AAUT) - the top tertiary teaching award in Australia

In July 2015, I received a National Teaching Fellowship from the Australian Office of Learning and Teaching (OLT). This was a Category 1 research grant and it was **the first time a journalism educator in Australia had received this prestigious Fellowship for leadership in learning and teaching**. Before this, I was part of a team of researchers, led by Professor Lelia Green, that secured a national Australian Research Council (ARC) Linkage Grant to research online support for heart patients. I also joined a team of researchers, led by Professor Stephen Tanner from Wollongong University, that secured a national OLT Development Grant to research graduate skills and industry needs. These three grant awards provide evidence of national recognition of my research credentials and my long-standing commitment to journalism education and health research.

These awards are further supported by a long list of peer-reviewed book chapters, journal articles, conference publications, international workshops, and two websites that were created to share my research findings - www.aidsreporting.com and www.journalismcapstoneunits.org

I was appointed as a Research Associate at the Pacific Media Centre, based at Auckland University of Technology (AUT) in New Zealand in recognition of my research work on media coverage of health and HIV in the Pacific. I have directed workshops on health and HIV in several countries in Asia and the Pacific. Currently, I am a Grant Assessor for the Australian Research Council.

OLT National Teaching Fellowship 2015, \$155,311.

This was the first time a journalism educator in Australia had been awarded the prestigious life-long Fellowship. It is a Category 1 research grant that aims to create agreed guidelines to facilitate the demonstration and measurement of graduate skills and capabilities in 29 universities in Australia that offer degrees in journalism.

European Commission Grant - 2013 – 2016, \$123,000

I was one of four successful ECU researchers, led by Prof Lelia Green, that secured an European Commission sponsored IRSES project that aims to build the theory, research and practice on the use of narratives in health communications. I worked with Prof Markus Appel at Koblenz/Landau University in Germany in June 2014 where I conducted two research seminars for staff and students on health narratives and one workshop on health journalism.

ECU Industry Collaboration Grant - 2014 – 2015, \$51,006.

This project seeks to engage media as key partners in stemming rising HIV and STD infections in WA. In collaboration with the WA Aids Council, Associate Professor Trevor Cullen, Head of journalism at Edith Cowan University, will develop and deliver a pilot media education programs (MEP). This program will enable the media and health professionals to work more effectively to share and convey accurate and balanced information to a wide range of audiences in WA on both HIV and STIs. The MEP will consist of a mix of media training and education programs for staff at the WA AIDS Council staff; people living with HIV (PLWH) and health and medical writers in WA. The project will draw from the successful 'Mindframe' national media initiative that has resulted in significant improvements in the reporting on mental health and suicide (Mindframe, 2014). The goal is to foster improved and responsible media reporting on HIV and STDs which will allow for better understanding and response to these diseases.

Australian Learning and Teaching Council Grant, 2012 – 2013, (\$120,000)

For this project, I conducted (in 2013) 12 face-to-face interviews with WA news editors at the ABC, Channels 7, 9, 10, *The West Australian*, *The Sunday Times*, *Community Newspapers*, WAToday and 6PR. The findings from these interviews were used in a national report (published in March 2014) on how news editors view Journalism education and industry needs.

- Gave a keynote address on the topic at the Mleague international educational conference, held at the Communication University of China on 27th September 2013, in Beijing, China.

ECU journalism program rated highly in Australia

The national organization, Graduate Careers Australia, which is recognized by the Vice-Chancellors of Australia, rated ECU's journalism program as one of the best performing programs in its 2010 and 2011 findings. It was the best performing university in terms of teaching and graduate satisfaction. These are the latest figures to date. ECU's journalism program was rated as one of the best performing universities for graduates to find media jobs when they completed their degree or postgraduate studies. The list included – Queensland University of Technology (159), RMIT (150), UTS (111) and Edith Cowan University (92). List compiled by Dr. Margaret Simons (journalist, author and journalism lecturer at Swinburne University). Roughly 29 out of 39 Australia Universities run journalism courses.

Organizer – National Journalism Education Association of Australia Conference (JEA)

In 2009, the JEA executive appointed me as convener of the national JEA annual conference. This involved organising the annual three-day national education conference which attracted media academics from the 29 universities in Australia that run journalism programs, together with overseas journalism and media academics from New Zealand, England, United States, China and the Pacific region.

The work involved finding a venue, forming an organising committee, setting up peer-review panels for abstracts and full papers, finding guest speakers, structuring and overseeing the three-day program, arranging consultative meetings with the Head of Journalism at Curtin and Murdoch universities and seeking financial support since the JEA did not finance the conference.

This was the first time that journalism staff at all three universities had worked together, and especially, on such an important educational project. The conference, entitled *Journalism education in the digital age: Sharing strategies and experiences* was held at the Burswood Intercontinental Hotel from 30 November - 2 December. Keynote speakers included ECU's Vice-Chancellor, Professor Kerry Cox, Eric Beecher, the publisher of Crikey.com, Mike Van Niekerk, Editor-in-Chief, Online, Fairfax Media, Brett McCarthy, Editor of the *West Australian* and Peter Van Onselen, political columnist with *The Australian* newspaper and *Sky News International*.

Vice-President of Journalism Education Association of Australia (JEA)

Elected as the JEA Vice-President in 2009, this position was both an honour and recognition of my 10 years membership and commitment to the organisation. It is the sole body in Australia that speaks on behalf of media and journalism academics. One of my main jobs was to convene a monthly, two-hour phone conference with the JEA executive committee in order to make decisions concerning the organizations and its members, and to report on JEA activities in Western Australia. www.jea.org.au

Reviewed journalism programs at University of South Australia

This review was commissioned by the outgoing Head of the School of Communication, Information and New Media, Professor Kerry Green on the instruction of the Pro Vice Chancellor of the Division of Education, Arts and Social Sciences, Professor Pal Ahluwalia. The site visit occurred between 14-18th February, 2012.

I was told that I was asked to be a reviewer because ECU's journalism program was rated as one of the best performing tertiary journalism programs in Australia by Graduate Careers Australia in 2010 in terms of graduate satisfaction with the course and the standard of teaching. The review report was sent to UniSA on 28th March.

During the visit we reviewed the structure of three undergraduate programs, including:

- The Bachelor of Journalism (MBO)
- The Bachelor of Journalism/Bachelor of International Relations (MBIR);
- The Bachelor of Journalism, Bachelor of Arts (Writing and Creative Communication) (MBW).

In 2014, I organised a series of media education and training sessions for both WA AIDS Council staff and HIV ambassadors. The aim was to empower people working in HIV or living with the disease to share their stories in the media. Media kits were prepared and later published.

Mind frame Advisory Committee - elected to National Board from 2009 - 2011 & 2011 – 2015

The Committee reviews the reporting of mental illness, depression and suicide in the media. The Committee meets twice a year in Sydney, and at least once a year an executive member from Mindframe travels to ECU to address the Health Journalism students.

Working with socially disadvantaged students at Mission Australia

I taught 15 students in first semester 2009; 10 students in first semester 2011 and 15 in first semester 2013. Basically, I ran a 13-week unit on *Introduction to Journalism* and also one on *Health Journalism*. I attended the last three Catalyst Clemente graduation ceremonies. In 2013 I became the program course coordinator.

The *Catalyst Clemente* program is for people whose social and economic circumstances have kept them from following traditional routes to Higher Education. The program gives them the opportunity to do accredited university courses in the area of the humanities. It is funded by Woodside's community initiative program. All the students have reached at least Year 10 and now, through this program, they can return to study, and if possible, qualify for first year university units at ECU. Ages range from 26 - 60 years and classes are frequently interrupted with smoke and coffee breaks. This works because the people who come are so keen to learn, despite struggling with personal problems or difficult domestic situations. Sometimes it is hard work to keep the people focused. I helped 8 students to graduate and begin their first year studies at Edith Cowan University.

Health journalism education projects in the Pilbara and Geraldton regions

From 2005 - 2011, I worked with the Combined Universities Centre for Rural Health (CUCRH) and the journalism program at Edith Cowan University (ECU) to promote a better understanding of Aboriginal culture and communities in Western Australia.

The long-term aim of this project was to improve media reporting of Aboriginal issues as many non-Aboriginal journalists never manage to meet and talk with Aboriginal people about their lifestyle and beliefs, and this often results in narrow and misinformed reporting.

In an attempt to respond to this current situation, eight final-year ECU journalism students were offered an opportunity by CUCRH to participate in a one-month journalism placement with Aboriginal communities in two Western Australian towns in July 2009, 2010 and 2011. At the end of the placement, the students were asked to prepare a brief written report on what they had learnt from the experience.

A common response was that the students had gained substantial knowledge and understanding of Aboriginal people (and about themselves), and that this new awareness would, they said, influence their reporting of Aboriginal issues.
