PROFILE

Lelia Green is Professor of Communications in the School of Arts and Humanities at Edith Cowan University. Prior to her appointment at ECU, Professor Green worked as a researcher, director and producer with BBC Television in London, UK. Her research interests focus on communications, the creative industries, new media, media policy, cultural studies, and the construction of community; including communities that are marginalised, disadvantaged or challenged by social factors, emotional issues, health status or distance. In addition to her MA and PhD in Communications, Professor Green holds a Masters in Education and a Master of Arts in Creative Writing, alongside a Graduate Certificate in Business (Management). Her undergraduate Honours degree is in Natural Sciences (Psychology).

Professor Green has been a Chief Investigator on 15 nationally competitive grants, 13 of which have been ARC grants, including two with the ARC Centres of Excellence program: in total she has (co)received \$15.5 million in funding. She first won an ARC grant in 2002, and since then has worked as a mentor and facilitator supporting the submission of high quality ARC grants at ECU. This has involved promoting the development of research within the University through working closely with early- and mid-career researchers to build their track records in research excellence, strengthening their confidence to think beyond their disciplinary boundaries.

In the past five years, Professor Green has been closely involved with three international networks funded by: the European Commission's Safer Internet Programme; COST Action networks; and, the 7th Framework Programme. As part of the latter project, she was a named Chief Investigator, a Work Package leader, and ECU team leader on a Marie Curie Actions International Research Staff Exchange Scheme (IRSES) project researching *Narratives in health communication* (2014-17). In 2014 she was a Visiting Fellow at the London School of Economics and Political Science (LSE), UK. Other long-term international collaborations include her work on the UN-supported biennial *Digital Review of Asia-Pacific* (2003-10) which was reprised, in part, in her role with UNESCO's Regional Consultation on "*Policies and initiatives to promote children's safe, effective and responsible use of ICT*" (Bangkok, 2015).

Professor Green has played a role on research advisory groups including the Centre of Excellence for Creative Industries and Innovation's Management Group, both as ECU node leader and as the head of the Risk and Representation Project. She was involved in the Research Quality Framework consultations (which was later re-cast as Excellence in Research for Australia), and was a funded participant in the Humanities disciplinary workshop. She also contributed to the deliberations around Panel 13, recognising the work of researchers in the Creative, Performing and Literary Arts. She has dedicated time and passion to University Committees and has served on ECU's Academic Board, the Vice-Chancellor's University Promotions Advisory Committee, the University Research and Higher Degrees Executive and Committee, the Research Students and Scholarships Executive and Committee, the Faculty of Education and Arts Executive and the School of Communications and Multimedia Executive.

Professor Green's publication record includes 3 books (with two additional edited collections recently contracted: by Routledge, and Springer), 21 book chapters, 145 peer reviewed publications, and an i10-index count of 28. She is a highly experienced Higher Degrees by Research (HDR) supervisor with 20 PhD student completions (including one currently in level (ii) revision) and 9 HDR students in progress. In recognition of her work in this area and her active mentoring and support of HDR progression, the national Office of Learning and Teaching awarded Professor Green a *Citation*

for Outstanding Contribution to Student Learning for leadership, commitment and success in learning and teaching through PhD supervision (2015).
