<b>COVID-19</b> Recommended: Evidence of completed primary dose course (usually 1 dose) *Show GP evidence on COVID-19 digital certificate or Immunisation History Statement (IHS). International students - present vaccination certificates from home country. <b>Required only where specified by the placement provider.</b>	Once only	
<b>Influenza</b> Evidence of most recent seasonal vaccination <a href="https://immunisationhandbook.health.gov.au/vaccine-preventable-diseases/influenza-flu">https://immunisationhandbook.health.gov.au/vaccine-preventable-diseases/influenza-flu</a> <b>J46- required for NPP6106</b> <b>C33 &amp; Y76- required for NPU1101 + NPU1202</b>	Recommended annually <b>*Required</b> for all residential aged care clinical placements	

SCREENING		
<b>MRSA Screening (nose &amp; throat swabs)</b> If you have been a patient or worked in a health care facility (including an older adult health care facility) outside of WA in the last 12 months you will need MRSA screening.  MRSA screening swabs can be collected outside of WA, as long as the individual has not worked since collection of the screening swabs.	Following any hospitalisation, clinical experience or employment in a health care facility outside of WA during your course	Student Vaccination Record (SVR) completed by health care provider uploaded to SONIA
<b>Tuberculosis Screening</b> Evidence of QuantiFERON or Mantoux	On commencement of the course & following any travel to countries identified as high burden TB countries by WHO <a href="https://www.who.int/tb/data/en/">https://www.who.int/tb/data/en/</a>	

Students are required to submit all clinical placement requirements to SONIA by the due date specified on the Clinical Placement Canvas site. Clearances should be valid for the entire semester period (PR7 or PR8).

Clinical placements requirements are an assessment item (portfolio) in all nursing/midwifery clinical practice units.

Please review Clinical Placement Canvas site announcements and Unit site assignments for due dates.

Do not upload documents in HEIC format as they are unable to be opened in SONIA and will not be processed.

Immunisation history statements (IHS) or individual serology reports will not be accepted as evidence of vaccinations, only the Student Vaccination Record (SVR) will be accepted.

Refer to the Clinical Placements Canvas site for specific instructions on obtaining each of these requirements.
