## S74 Graduate Certificate in Education (Early Childhood Studies)

This course is ideal if you're thinking about a career shift or expanding your teaching qualification into early childhood education from primary or secondary teaching - either in the early years of school, or into an early learning setting.

Successful completion of the course gives you an ACECQA recognised qualification that allows you to teach children in early childhood settings from birth to 8-year-olds. This course is designed by teachers, for teachers and can be completed in 8 months. It suits current teachers as practicums are completed in school holidays and, if you are already teaching an early childhood cohort, in your own school. This means you can continue teaching in your current role and location while studying.

Early childhood education is one of the fastest growing sectors across Australia, with high demand for fully qualified teachers. Completion of this course positions you well for school leadership roles, and pedagogical leadership in early childhood education and care settings.

#### Admission Admission Requirements (Band 8)

The following course-specific admission requirements are mandatory and must be satisfied by all applicants. These requirements are in addition to or supersede the minimum requirements outlined within the Academic admission requirements band section below.

All applicants are required to have a three-year or four-year primary or secondary teaching qualification, such as a Bachelor of Education (Primary), a Graduate Diploma of Education (Primary), a Bachelor of Education (Secondary), Graduate Diploma of Education (Secondary), Master of Teaching (Secondary), or Master of Education, with equivalents considered.

Academic admission requirements (Band 8) may be satisfied through completion of one of the following:

- · Bachelor degree in a cognate discipline; or
- Where accepted, equivalent prior learning, including at least five years relevant professional experience.

#### **Duration: 8 months part-time**

Please note: This course follows a non-standard delivery pattern to accommodate DoE Leap sponsored participants. This course information may be updated and amended immediately prior to semester.

## ECE6230: Constructing Curriculum in Early Childhood

This unit explores contemporary research and issues related to the construction of early childhood curriculum and the strategies educators employ to make it engaging, effective and appropriate for children birth to eight years. This unit will assist students with the development of inclusive pedagogy that facilitates children's holistic learning of early literacy and language, early mathematics and science, technologies, the arts, social and environmental education, and physical and health education. Students will explore how concepts across these areas are integrated and represented in meaningful ways for young children. Students will also explore the physical, temporal, socioemotional and intellectual components of the learning environment and how they are instrumental in curriculum implementation in early education.

#### **Learning Outcomes**

On completion of this unit students should be able to:

- · Apply knowledge of contemporary learning theory and pedagogical principles and practices of the Early Years Learning Framework (2.0) to plan across the curriculum.
- Evaluate a range of curriculum approaches and opportunities for engaging children in learning across curriculum areas, including emergent, integrated and inquiry-based approaches.
- Synthesise evidence-based research supporting play pedagogies for early childhood.
- · Critique and plan high quality learning environments that demonstrate responsive pedagogy for children birth to eiaht.

#### **Unit Content**

- 1. Characteristics of an emergent curriculum and elements of effective play-based pedagogy and learning
- 2. Theories of learning and development for children, and implications for pedagogical practice and the learning environment.
- 3. Early childhood pedagogical principles and practices to foster positive attitudes and life-long learning across the curriculum.
- 4. A range of pedagogies and opportunities for engaging children in learning across key curriculum areas examining integrated and inquiry approaches.
- 5. Ethical approaches to promoting child wellbeing, holistic development, health, and safety.
- 6. Early childhood mandated curriculum frameworks.

## ECE6240: Child Development for the Early Years

Note: The professional experience requires the student to attend the professional experience on a fulltime basis (8 hours per day) and meet specific attendance requirements. There is limited scope for ECU to negotiate any deviations from these requirements.

This unit examines the construction of childhood in society. It draws upon multiple disciplines and perspectives to understand a child's conceptual development holistically. While this unit has a neurological basis, the developmental domains of social-emotional, language, cognitive and physical are studied so that the most effective pedagogical decisions can be made for young children. Students will review and employ the unit content and mandated regulatory documents e.g. the National Quality Standard and the Early Years Learning Framework V2.0 (2022) whilst on a birth to three professional placement to demonstrate pedagogy that is responsive, collaborative and inclusive. Students will actively communicate and collaborate with families and colleagues to plan and implement high quality care and educational opportunities. Designated unit: This professional experience unit is deemed to be a fundamental course requirement and may only be attempted once unless otherwise determined by the Progression Panel. Failure to pass these units may result in exclusion from the course.

#### **Learning Outcomes**

On completion of this unit students should be able to:

- Evaluate National Quality Standards and the Principles and Practices of the Early Years Learning Framework V2.0 to programs birth to eight years.
- Design and implement curriculum and care experiences that promote the well-being, safety and holistic development of infant and toddlers through play-based approaches.
- · Collaborate within teams and families to include all children in ethical and culturally responsive ways.
- Critically reflect on the impact of pedagogical decisions.

#### **Unit Content**

- 1. Children's neurological, social-emotional, language, cognitive and physical development.
- 2. Constructions of childhood, theories and perspectives of growth and development and the conditions that influence them.
- 3. Early childhood education that promotes positive growth, wellbeing, safety, development and learning through play.
- 4. Evidenced based plans, observations and inclusive early interventions.
- 5. Practices that promote cultural responsiveness, diversity, Aboriginal and Torres Strait Islander perspectives, collaboration and engagement with families.
- 6. The National Quality Standard and the Early Years Learning Framework V2.0.

## ECE6250: Advocating and Leading in Early Childhood

This unit will critique historical, international and comparative perspectives in early childhood education and investigate issues that impact on policy development and implementation. Students will critically analyse international trends in early childhood education and curriculum approaches relating to early childhood education. The development of the early childhood educator's professional identity will be explored and the ethical responsibilities of early childhood educators scrutinised. Students will critically examine the knowledge and skills needed for leadership, working in teams and the administration of early childhood programs. Advocating for quality early childhood programs, this unit will assist students to explore the many facets of work of the early childhood educator as a pedagogical leader in early childhood education.

#### **Learning Outcomes**

On completion of this unit students should be able to:

- · Critique perspectives of early childhood education and contemporary issues that impact policy affecting young children.
- Build an early childhood philosophy including professional, ethical, legal and advocacy responsibilities.
- · Critically examine knowledge and skills needed to lead, work collaboratively, and administer early childhood programs.
- Design sustainable, culturally responsive practices for building partnerships with children, families and relevant stakeholders for effective transitions across early childhood education and care contexts and settings.

#### **Unit Content**

- 1. Contemporary, historical and comparative perspectives in early childhood education and the Australian early childhood policy agenda.
- 2. Early childhood educator's professional identity and the ethical and legal responsibilities of early childhood educators.
- Compliance and quality improvement processes in alignment with the National Quality Standard; the EYLF; the Australian Curriculum; the United Nations Convention on the Rights of the Child, the ECA Code of Ethics, including mandatory reporting and duty of care.
- 4. Working, leading and administrating programs with teams in early.
- 5. Sustainable, culturally responsive practices for effective transitions during early childhood.
- 6. The role of educators as advocates in response to contemporary issues.

## ECE6260: The Art of Early Childhood Pedagogy

Note: The professional experience requires the student to attend the professional experience on a fulltime basis (8 hours per day) and meet specific attendance requirements. There is limited scope for ECU to negotiate any deviations from these requirements.

This unit explores the specialised knowledge and skills related to effective teaching and learning of young children and the effective planning, implementation and the assessment of inclusive and socially just curriculum. The students will revisit the historical and comparative perspectives of early childhood education and link these theoretical frames to the practice of educating young children. The unit will also explore the essential skills to plan and implement effective learning programs that utilise contemporary, play-based pedagogies. This unit will include professional experience days as applicable to the course registration requirements. Designated Unit: This professional experience unit is deemed to be a fundamental course requirement and may only be attempted once unless otherwise determined by the Progression Panel. Failure to pass this units may result in exclusion from the course.

#### **Learning Outcomes**

On completion of this unit students should be able to:

- Critically analyse theories and models of effective early childhood pedagogy.
- Examine and implement effective practice for creating inclusive and differentiated curriculum for children.
- · Critically analyse effective teaching and learning strategies for the inclusion of children from diverse cultural and developmental backgrounds including working with families and communities.
- · Independently plan, implement, and assess ethical early childhood programs considering contextual factors, while on professional experience.

#### **Unit Content**

- 1. Theory, policy and research on diversity and inclusivity underpinning effective early childhood pedagogy.
- 2. Effective practice for creating inclusive early childhood environments that invite full participation of all children.
- 3. Characteristics of children with complex needs e.g., Autism, Attention Deficit Hyperactivity Disorder (ADHD), Trauma-affected children, Difficult Behaviours.
- 4. Effective strategies for working in partnership with families and communities considering diversity and difference.
- 5. Planning, implementing, and assessing early childhood programs through an ethical lens of learning context and inclusion.

## Frequently Asked Questions



#### What is the Leap program?

The Leap program refers to a postgraduate qualification for DoE sponsored teachers typically consisting of a Graduate Certificate. A graduate certificate is made up of four tertiary academic units (AOF level 8).

#### What costs are covered by the Leap program?

DoE supports teachers to participate in the Leap program by paying for course fees and essential course materials. DoE determines who is Leap sponsored, typically DoE sponsors teachers for one attempt at each unit within the nominated Leap course at ECU. Permanent and fixed term DoE teachers are also supported with travel and accommodation where required. Please note that DoE does not cover ECU's Student Services and Amenities Fee (SSAF).

#### What is the Student Services and Amenities Fees (SSAF)?

Whilst DoE cover most costs relating to the Leap program you are personally liable for the 'SSAF' fee. This fee is payable each Trimester. Your Statement of Account (invoice) is available by logging into SIMO (see page 14).

#### **Census & Academic Penalty Dates**

Please take careful note of the Census and Academic Penalty Dates for each teaching period. If withdrawal occurs after these dates, you may be personally liable for payment of the unit and an academic penalty may be applied to your student record.

#### Am I paid to complete a Leap course?

DoE teachers are not paid to undertake sponsored Leap postgraduate courses. Fixed term and permanent DoE teachers continue to be paid by their school as per their normal contract conditions.

#### Can I enrol in this program even if I don't work for the Department of Education?

The short answer is yes! This will depend upon the availability of places as Department of Education teachers are given priority. Please contact the DoE WA directly to make enquiries regarding potential sponsorship via leap@education.wa.edu.au.

This course follows a trimester teaching pattern to accomodate In-Service Teachers; to commence the application process, please email <a href="mailto:leap@ecu.edu.au">leap@ecu.edu.au</a>.

#### How do I use my relief days?

Relief days are sent to your school for the time you need to be out of the classroom for study, course work, revision sessions and exams for your Leap course.

Each DoE teacher may have a different amount of relief based on the course and your work fraction, so please check this with DoE when you first commence the Leap@ECU sponsored program. When using relief days, line manager approval is always required. Whilst some relief days are fixed for exams and revision sessions, study days are flexible. Please negotiate with your school to minimise disruption wherever possible. Please also discuss with your line manager that you are completing your study at ECU. You do not need to submit leave on the Human Resources Management Information System (HRMIS) as you do not use any of your leave credits.

#### How do I apply for an assignment extension?

There may be instances that are unexpected and out of your control that may adversely impact on your ability to submit an assessment item by the due date. For details on how to apply for an extension please visit: https://askus2.ecu.edu.au/s/article/000001386

#### Where do I get an ECU student ID card?

You can get your student ID card from any of our eLab counters on campus, where your photo will be taken, and your card will be produced while you wait. If you are off campus you need to complete the application for a student ID card and submit it with a passport size photo of yourself as directed on the form.

#### Can I complete this course online?

The Graduate Certificate (Early Childhood Studies) is delivered online across Trimesters 1 & 2, with the exception of the Professional Experience placements.

#### What happens if I fail one or more units in my **Graduate Certificate course?**

There is no guarantee that DoE can support you to reattempt a unit if you fail. This will require a discussion with your DoE Leap Coordinator about what occurred and what sort of plan can be put in place to support successful completion of the course at ECU. There may also be other factors that need to be considered. #### What are the professional experience requirements for this course?

This Graduate certificate requires you to complete two professional experience placements across three different settings:

- Birth to three-year-olds setting in an early learning setting (15 days)
- Three- to five-year-olds in a preschool setting, which can be a kindergarten on a school site (15 days)
- Five to eight-year-old school setting (30 days)

#### Can I get formal recognition for my previous teaching experience for any of these professional experiences i.e. recognition of prior learning (RPL)?

If you are a qualified Primary Educator, it is possible to receive RPL for the five-to-eight year-old setting (i.e., 30 days). Due to ACECQA requirements, NO RPL can be granted for the birth-tothree or the three-to-five yearold setting.

N.B. RPL will be granted by the Course Coordinator, Dr Amelia Ruscoe, upon acceptance into the course

#### Can I decide when to complete my professional experiences?

No. The professional experiences have been carefully planned to accommodate working professional educators. Placements in early learning centres are timed to coincide with school holidays. School-based placements are timed during Terms two and three, and in some instances can be completed in your own classroom setting.

#### Can I complete the professional experience placements in my own workplace?

Yes, this is possible with the agreement of the Centre Director or the school Principal.

#### Tell me more about the four academic units

The course is made up of four academic content units and two integrating professional experience placements. These academic units are at AQF level 8 i.e. post-graduate level. The units are delivered entirely online. In each unit, there will be three synchronous collaborative meetings that you are expected to attend; these are timed for afterschool hours to accommodate working professionals. The course content has been streamlined so you will study only one unit at a time.



#### How do I get started?


This course has been specifically designed to commence with an online Orientation module to help you navigate the course structure. Orientation commences the week of 5 January 2026 and will take approximately 5-10 hours. This orientation includes a professional experience hub, an introduction to key early childhood documents (e.g. National Quality Framework and NQS, EYLF2.0) and an academic support module to help you transition back into postgraduate study.


### What's Next?



## Tips Once you have Enrolled

#### Regularly check your ECU email

Any updates regarding your unit content and enrolment will typically come through your student email.

#### Log in and check Canvas

Canvas is an online environment that supports learning by providing a suite of tools to enhance and extend the learning experience for our students, as well as providing some efficiencies for our teaching staff. Canvas contains unit outline documents and study information for units in which you are currently enrolled.

The information varies from one unit to another, but generally all Canvas course sites will provide you with:

- · Lecturers contact details;
- · Important announcements;
- Unit outline;
- · Lecture notes; and
- Assignment submission areas.

If you are studying an online unit, Canvas provides all the learning materials needed, including completing tasks, quizzes and assignments using for example, the discussion board and ePortfolios.

#### **Get familiar with the Schedule of Work**

The Schedule of Work is a document that outlines all the requirements and expectations of the unit including key contacts, key assignment dates and unit content. You will be able to access your Schedule of Work on Canvas one week prior to the commencement of the unit.

## Intermitting or Withdrawing from a Leap Sponsored Course or Unit

Should you need to withdraw from a unit or discontinue/intermit from a Leap sponsored course there are a few things you need to do first.

Firstly, please contact the **DoE Leap team** and discuss your situation and circumstances. Please then advise your unit Lecturer of your situation. DoE will then liaise with ECU to work on the best solution based on your circumstance.

#### Need to withdraw after census?

If the census date has passed (see page 4) you may still withdraw from a unit, please be aware that:

- If you withdraw after the census date, you may be liable for the full costs of your tuition fees
- If you withdraw after the Academic Penalty Date and up until midnight prior to the beginning of exam period, the unit will appear on your academic record with a WF (withdraw fail) grade. After this time, your academic record will show a fail.

To be considered to have the financial liability or an unsuccessful grade removed due to unforeseen special circumstances it is possible to make an application to withdraw without penalty.

## Withdrawal without penalty - eligibility to apply

You can apply online for withdrawal without penalty if you satisfy the two requirements below:

- You have not successfully completed a unit/s; and
- 2. You apply within the application period, either within 12 months from the date of withdrawal, or if you have received a result for the unit, within 12 months from the end of the study period.

#### **Special circumstances**

To be eligible for withdrawal without penalty, in your application you must be able to demonstrate that you have been impacted by special circumstances that meet the three required conditions below:

- The circumstances were beyond your control;
- The circumstances made their full impact on you after the applicable penalty date; and
- The circumstances have made it impracticable for you to complete the requirements for your unit(s) of study.

#### **Supporting documentation**

The documentation you submit to support your application must be from an independent relevant authority (for example, a doctor, psychologist or employer etc). A supporting letter from your family or friends is not considered independent. The documentation is required to be in an official format (for example, a medical certificate or company letterhead displaying ABN, authors contact details, position and the date the document was produced.).

If you are applying on medical grounds we recommend you provide a completed Medical/Health Professional Assessment form to assist with the assessment of your circumstances, please note however this is not a requirement.

## Attendance, Participation and Important Information

Your attendance at Professional Experience and participation in online learning tasks, discussion boards and synchronous meetings are essential to the successful completion of a unit.

If you do not meet expectations for attendance and participation, you may be required to meet with the unit and/or course coordinator; and if determined by the course coordinator you may be required to meet with the Associate Dean (Postgraduate Studies) for the purpose of discussing your enrolment and progression.

#### **Recording of Lectures**

You should be aware that recorded lectures may contain copyright material owned by ECU, the relevant lecturer and/or other third parties. If you wish to record lectures in this unit you must contact the lecturer to obtain the express written consent, and comply with any conditions, of the relevant lecturer or performers.

Where written consent is not obtained, you must not reproduce, communicate, modify, adapt, broadcast or distribute their recording of this lecture and should be aware that such acts may constitute infringement of copyright and/or performer's rights.

#### **Important Assignment Information**

ECU's School of Education students are required to use the APA 7th referencing style. Referencing guides and online resources are available to help you reference your academic work. ECU subscribes to APA Style CENTRAL, a digital library of APA Style quick guides and video tutorials. All these resources can be accessed through the Library website.

Assignments are uploaded to a platform called 'Turnitin'. This checks for plagiarism. It is the responsibility of each student to keep an electronic copy of their assignment and as proof of submission, their Turnitin receipt.

It is the endeavour of all unit coordinators to return assignments to students within a two week timeframe from the due date. However, the assessment and moderation process in units where there is more than one tutor may require an extension of this time. Unit coordinators will advise students when this is the case.



#### **Academic Misconduct**

You must comply with ECU's Academic Misconduct Rules. The Misconduct Rules consider any form of plagiarism, unauthorised collaboration, cheating in assessment tasks, theft of another student's work, any other dishonest or unfair conduct relating to academic work to be Academic Misconduct.

Plagiarism means knowingly or unknowingly presenting as one's own work the ideas or writings of another without appropriate acknowledgment or referencing. A student engaging the services of another individual to complete an assessment task on their behalf is both plagiarising and cheating. ECU takes all incidents of Academic Misconduct seriously and if, following an investigation, it is established that a student's conduct amounts to Academic Misconduct then ECU may impose penalties upon the student under the Misconduct Rules.

#### **Learning Management System**

Canvas is ECU's Learning Management System (LMS), which provides the main interface to the student digital learning environment for learning materials, assessments and interactive online learning activities.

It is important that you have reliable access to an Internet connection and a computer or appropriate mobile device (ideally with a microphone and camera). For online students, you can log into Canvas daily.

#### **Browsers**

**Chrome** and **Firefox** are the recommended browsers, please keep your browser up to date for the best experience. If one browser does not load or display as expected, please try another, or try clearing your browser's site data.



Congratulations on completing all four units in your Leap Graduate Certificate. The Graduate Certificate of Education (Early Childhood Studies) is made up of four tertiary academic units (AQF level 8).

Once your marks have been ratified by the Board of Examiners and have met the official requirements, your S74 Graduate Certificate of Education will be granted from ECU.

















#### **Second Step**

You'll need to respond to your Invitation to Graduate on SIMO. Once you have logged in to SIMO, you will need to select Graduation from the menu and then click Ceremony Registration.

- Accept this will confirm your attendance at the ceremony, ensuring you receive your formal academic testamur.
- **Defer** you can defer your attendance by up to 12 months. You'll receive an invitation to the next round of graduation ceremonies and will need to register again via SIMO.
- Decline you won't receive an invitation to graduate at any future ceremonies for your current award. You can choose to have your testamur posted to you, or you can collect it from Student Records.
- Ignore if you don't accept, defer or decline your graduation invitation on SIMO, you won't be eligible for any future graduation ceremonies for your current award, and your testamur will not be produced. We don't recommend this!
